****Call for volunteers for the Michigan Gun Owners BoD and Election Committee****

Call to Members:
It's time once again to elect volunteer members to the Board of Directors and the Election Committee.

This is a call to Contributing Members to run for election. If you want to be more involved in the direction of MGO, then this is a call to you.

Interested Candidates should contact the Election Committee (jolari, Kaeto, or CircuitRider) via PM as soon as possible.

NOTE: Members who wish to volunteer for the BOD or the Election Committee are required to do so no less than 35 days before the election.

The Board of Directors shall consist of not more than nine, nor less than five qualified members, elected to two year terms, with expiration's staggered and positions filled into two classes. Class "A" Directors terms shall expire in odd numbered years and Class "B" Directors shall expire in even numbered years.

Qualifications needed to run for the Board of Directors:

1) Must be a Contributing Member at least 21 years of age.
2) Must have been a Contributing Member (full voting rights) for at least 1 year prior to running for election.
3) Must agree to maintain Contributing Member status during his/her term on the Board.
(4) Class "A" $2 y r$ term seats are up for the 2015 election to the Board of Directors.

Once elected, the positions of BoD members are voted on and decided the first BoD meeting following the election. Any current or newly elected BoD member may fill any position at that time.

These are the positions currently held by the BoD members who's terms are expiring this year:

The Election Committee shall be a full time standing committee and shall consist of three full time members. The Election Committee shall be elected by the membership for a two year term, with no more than two seats up for reelection at anytime.

Qualifications needed to run for the Election Committee:

1) Must be a member in good standing of the corporation.
2) Must take and sign an oath to faithfully and impartially carry out the duties of the Election Committee to the best of his or her ability.
(1) 2 yr seat is up for election to the Election Committee.

Once elected, the positions of Election Committee members are decided online following the election. Any current or new Election Committee member may fill any position at that time.
